1. Introduction

- 1.1** In accordance with Section 15 of the *Procurement Reform (Scotland) Act 2014*, the Council published its Sustainable Procurement & Commercial Strategy (Strategy) for the period 2021 to 2026. Section 18(2) (a) of the *Procurement Reform (Scotland) Act 2014* requires the Council to detail “...a summary of the regulated procurements that have been completed during the year covered by the report”.
- 1.2** This Annual Procurement Report (APR) outlines the key elements of regulated procurements for the period 1 April 2024 – 31 March 2025. Regulated procurement refers to any procurement from £50k for Supplies and Services contracts and from £2m for Works contracts. A regulated procurement is completed when the award notice is published or where the procurement process otherwise comes to an end. Regulated procurements can refer to procurements delivered through new contracts or from utilising framework agreements (FA) or dynamic purchasing systems (DPS).
- 1.3** The Strategy is closely aligned to the Council’s vision, values and ethos and describes the role procurement has in supporting the delivery of the Council’s Strategic Plan. It sets out the key procurement objectives of the Council for 2021 to 2026. The delivery of these objectives will support the Council as it continues to face significant challenges, including:
- Resilience planning;
 - Cost of living crises;
 - Inflation in cost of supplies and global supply chain shortages;
 - Building a stronger community through commissioning services which aim to give more power to the community and promote community action;
 - Supporting services to meet financial requirements;
 - Continuing to proactively engage with all sectors across the local economy;
 - Sustainability and Climate Change duties
- 1.4** Appendix 1 and Annex A to D sets out the regulated procurement achievements, actions and future plans for the Council, which includes West Dunbartonshire Health and Social Care Partnership (WD HSCP). The Scottish Government’s Annex A: Summary of Regulated Procurements, is detailed in this report.
- 1.5** The Council also maintains a public [Contract Register](#) which provides information on current contracts.

2. Summary of regulated procurement completed

2.1 Details of regulated procurements awarded by the Council between 1 April 2024 and 31 March 2025 can be found at Annex B: Regulated Procurements and Annex A.

2.2 Collaborations with other public bodies to maximise mutual benefits, where appropriate, are included in the regulated procurements. This includes Scottish Government, CoSLA, Crown Commercial Services, Scotland Excel and the Council all acting as the contracting authority when procuring Supplies, Services and Works.

2.3 Number of regulated contracts awarded without a competitive procurement process was zero.

3. Review of regulated procurement compliance

3.1 Based on an analysis of spend data, of the £219,758,175 total regulated procurement spend, 89.5% / £196,600,529 (Council and West Dunbartonshire Health and Social Care Partnership) was compliant with regulated procurements. As a subset of this spend, the Council only expenditure (i.e. total spend excluding Health and Social Care Partnership) totalling £161,134,010 regulated procurement spend, 95.9% / £154,590,300 was compliant with procurement regulations.

3.2 The summary detail is shown in Annex C: Non-Compliant Regulated Spend and also highlights where further work is required to achieve increased rates of compliance. Where there has been non-compliance with procedures, this is partly due to separate spend from different Council departments which when combined, is higher than Financial Regulation limits.

4. Social (community) benefits summary

4.1 The Council is committed to working with our local community and businesses to maximise local social value.

4.2 The Council has implemented specific clauses within procurement contracts of more than £50k, known as social benefit clauses. Social benefit clauses are requirements which deliver wider benefits to our local community in addition to the core purpose of a contract. These clauses can be used to build a range of economic, social or environmental benefits into Council contracts through a range of options which may include, but are not limited to:

- Employment, work experience, training or modern apprenticeship opportunities;
- Education engagement and curriculum support activities;

- Support for community and environment projects through donation of money, labour, equipment or materials; and
- Other initiatives to support and develop local businesses, community groups and the local third sector

4.3 The social benefits questionnaire is part of the procurement documentation issued to all bidders of Council tenders and includes target social benefits points based on the annual value of the contract. This is a transparent, fair and accountable approach for assessing the impact of Social Benefits. In FY24/25 social benefits totalled:

Examples of a social benefit good news stories in 2024/25 include:

- Work Connect
Muller donated £2600 to Work Connect in order to allow them to install electricity points in their new woodwork facility based in Levensgrove Park.



Laura Parker, Work Connect:

‘The money generously gifted from Muller has allowed us to install electricity points within our newly converted woodwork facility. Our staff and service users had undertaken this conversion last winter as we needed a space to work when the weather made gardening tasks difficult (often!). This area provides us with a warm, dry area to learn many new skills such as making planters to sell in the community which allows us to keep supplies topped up and to donate items to other local community groups. Clients have also been upcycling old furniture and learning to make other small items. The wood-work room has been a fabulous addition to our facility, and we hope to extend the use to other organisations for their own learning opportunities. The installation of the electricity even means we will have the luxury of heaters in the winter months!!!’

- Affordable housing and social benefits at Willox Park
McTaggart Construction and West Dunbartonshire Council have joined forces to bring affordable housing and community benefits to Willox Park. This collaboration marks the announcement of a 17-unit affordable housing development that not only introduces new homes but also seeks to strengthen the local community.

Knowetop, situated on 15.5 acres in Castlehill, Dumbarton, serves as a hub for horticulture and wildlife initiatives that support the community's wellbeing. Through a range of activities such as volunteering opportunities, work placements, community events, and community food growing, Knowetop plays a vital role in engaging and supporting the local residents.



As part of their commitment to community benefits at Willox Park, McTaggart Construction and Tough Construction have teamed up to carry out essential civil works. This collaborative effort has successfully laid the groundwork for creating community assets such as a

community fruit orchard, allotments for residents, and a designated space for educational and social workshops. The positive feedback from project staff and volunteers highlights the potential for these initiatives to benefit hundreds of people annually by enhancing educational opportunities and promoting mental and physical wellbeing.

Gary Hassan, Commercial Director at Tough Construction, commented: “Tough Construction are committed to supporting the communities in which we work. This was a fantastic partnership project to support the Willox Park community benefits. We are pleased to have carried out this work and are confident it will benefit countless residents.”

The partnership between McTaggart Construction, West Dunbartonshire Council, and Tough Construction underlines a strong commitment to not only delivering much-needed affordable housing but also investing in the social and environmental wellbeing of the community. The establishment of the orchard, allotments, and social space is expected to provide lasting benefits to residents of Willox Park and the surrounding area.

McTaggart Construction's innovative approach to community benefit projects aligns with their goals of supporting communities and the environment. By supporting projects like Knowetop, they aim to positively impact hundreds of WDC residents, showcasing the broader influence of their partnership with West Dunbartonshire Council beyond physical structures.

- Lomond Community Food Pantry
Lomond Community Pantry would not have been able to be open to our community today if it were not for grants, funding applications and the kindness of donations from local businesses and social benefit contractors through West Dunbartonshire Council's Working 4U team.



When we met David Wilkie, he advised us to create a Wishlist of things we would need to enable the project to continue. We listed skips, slabs, edging stones, builders' sand,

shelving, fridges, freezer, painting and of course money to enable us to buy food to set up our initial stock.

The donations started to come in thick and fast. David arranged a meeting with Leigh from JM Murdoch who provided the skip needed to clear the hall and later the building sand required for a new pathway to be laid from pavement to hall plus a cash donation. David continued on behalf of the pantry to liaise with WDC contractors to work his way through our wishlist. The pathway and slabbing of the outside area required 400 slabs which were kindly donated by McConnell which was a cash equivalent of £3792!!! The edging stones were donated by McNairs Building Supplies. We then received further cash donations from Walker Love, Allsports Construction & Maintenance, Hawthorn Heights, FCA Fostering, NEC Software Solutions, Enva, CCG, and a very generous donation from Arnold Clark.

Without these donations and funding, the Lomond Community Pantry would not be able to help ease food poverty in our local area. Since opening in October 2024 we have 200 members registered and can foresee the numbers rising.

The pantry offers a warm space, a space to chat, to meet others and to let our members know that our community cares as reflected in all our kind donations received which allowed the idea of the pantry become a reality.

4.5 A first ever joint West Dunbartonshire Meet the Real Buyer event took place on 27 March 2025, at Golden Jubilee Conference Hotel. In total there were nine exhibition stands, which included West Dunbartonshire Council Procurement Team, West Dunbartonshire Council Business Support, West Dunbartonshire Council Health and Social Care Team, West Dunbartonshire Council Housing Team, NHS Golden Jubilee, NHS Greater Glasgow & Clyde, Scotland Excel, and Supplier Development Programme and Working4U.



This free event gave suppliers in the Central Belt of Scotland access to buyers and decision makers from across the public and private sector, helping suppliers raise their profile as a business, and prepare for upcoming contract opportunities.

In total, 462 suppliers had pre-registered interest on the SDP website for West Dunbartonshire Meet the Real Buyer 2025. There were 233 actual attendees on the day. Those attendees represented 140 Scottish SME unique businesses. 16 (11%) of those SMEs in attendance were from businesses based in the West Dunbartonshire area.

A post event survey highlighted:

- 75% of respondents rated the exhibitors as 'excellent' or 'good'.
- 64% of respondents rated the event as 'excellent' or 'good'.
- 67% of respondents said that they were more likely to bid for contracts after attending this event.
- 58% of suppliers felt more capable of bidding for contracts after attending the West Dunbartonshire Meet the Real Buyer 2025.

5. Supported businesses and social enterprises

- 5.1** Unfortunately, as there is not a central directory which supported businesses and social enterprises must register, it can be difficult to clearly identify spend in this area.
- 5.2** A supported business' primary aim is the social and professional integration of disabled or disadvantaged persons. At least 30% of the employees of those businesses must be disabled or disadvantaged. This is delivered, not only through the supplies, services and works they deliver, but also by providing meaningful employment, training and social support for those who may otherwise be excluded from the workplace.
- 5.3** There was no regulated contracts awarded to supported businesses during 2024/25 (noting the point in 5.1 that this can be difficult to identify). However, in 2024/25, the Council had spent with supported businesses including regulated contracts awarded before 2024/25 and non-regulated spend:

- 5.4** Social enterprises aim to make a profit but unlike traditional businesses, they reinvest or donate their profits to create positive social change. They empower communities, tackle social problems and create jobs - particularly for people who are at a disadvantage in the standard jobs market.
- 5.5** From the internal and external data that was available on social enterprises, there were three regulated contracts awarded to social enterprises within 2024/25:

6. Sustainability

- 6.1** The sustainable procurement policies and guidelines from the Scottish Government identifies a range of policies, tools and procedures that enable compliance with the Sustainable Procurement Duty. Further, the Council produced a [Climate Change Strategy](#) and [Action Plan](#) to set out the foundations for a plan of action and response to Scotland's Climate Emergency and 2045 net zero carbon reduction target.
- 6.2** Everything procured, from construction works to waste services to janitorial supplies has an impact on the environment and society. Therefore, the Council is able to make a positive contribution to sustainability through its procurement decisions. The [Sustainability in Procurement Guidance](#) details how the Council will meet its commitments to sustainable procurement.
- 6.3** The Council utilised the Scottish Government Procurement Sustainability Tools to contribute to the Council's compliance with Sustainability Duties including Climate Change Duties and Circular Economy. Procurement include sustainability within all

procurement strategies and ask questions to ensure that our supply chain are committed to climate change improvements.

7. Future regulated procurements

7.1 Over the next two years, there will be a mix of recurring requirements and one-off opportunities. A summary of procurements anticipated in the next two years is provided in Annex D: Future Regulated Procurement. This doesn't include ad-hoc or reactive requirements and until full scoping activities are undertaken and the contract strategies are complete, the timeline, contracting approach and values may be subject to change.
